
Elections will be coming up toward the end of the year so start thinking if you would like to serve.

- From the bylaws here are the duties of the offices that are up for election:

**E. President.** The president shall be the chief executive officer of the chapter. His/her duties include: supervise and control all the business and affairs of the chapter; conduct chapter meetings; any other actions which may be necessary to carry out the preceding duties effectively.

**F. Vice-President.** In the absence of the President or in the event of his/her death, inability, or refusal to act, the vice-president shall perform the duties of president, and when so acting shall have all the powers of and be subject to all the restrictions upon the president. The vice-president shall perform such other duties as from time to time may be assigned to him/her by the president.

**G. Secretary.** The secretary shall keep the minutes of the chapter meetings in one or more books provided for that purpose, and see that all notices are duly given as provided for in these bylaws. In general, the secretary shall perform all duties incident to the office of secretary, and such other duties as from time to time may be assigned to him/her by the president.

- I speak from experience that the secretary position is fun and does not take too much effort. The majority of the effort involves taking notes during the meetings, generating the newsletter then e-mailing it out. Much better than the old days of snail mail. The webmaster will still take care of the pictures and website.

### MESSAGE FROM THE PRESIDENT

It seems like just last week that the Guild got back together and started holding regular meetings. It seems like last week until you reflect on what has been accomplished in those 4 short years. And they do seem to be getting shorter.

A web site was set up and it is constantly being updated and improved. This is a great tool for getting information out to members and guests. I personally have had contacts from people all over the world who have visited this site.

We established a goal of bringing in a guest demonstrator once a year. As a result we have been fortunate to bring in some very big names and outstanding demonstrators in the likes of Clay Foster of Texas, Graeme Priddle of New Zealand, Alan Lacer of Minnesota, Jimmy Clewes of England and Al Stirt of Vermont. All of these are outstanding Woodturners, artists, demonstrators and teachers. I can only say if you have not seen at least one of these outstanding demonstrations, shame on you.

Last year we were fortunate to establish a relationship with Bozeman High School. As a result of this relationship we were able to have the last two demonstrations at the high school and as a result a few hundred students have had the opportunity to be exposed to a world-class Woodturner. Guild members have also been mentoring students in the wood shop.

One of the first orders of business when the guild got back together was to become a chapter of the American Association of Woodturners. The AAW has been very supportive of our group and has helped financially when we have sought their support. They helped us bring in the first guest demonstrator in 2003 and last year they helped us purchase a new Powermatic lathe. The AAW also provides liability insurance that protects the guild at official guild events.

These are some of the accomplishments that I can recall from the past few years. As a group like this develops and grows it takes on a direction and personality of it's own. This is not a club of the president or any of the officers; this is a club of the members. I hope the membership is happy with the current course and accomplishments.

It is time now to elect new officers. Although being an officer is not a tremendous amount of work there is some work involved. There is also some responsibility in helping to shape the guild and the direction it is going. The guild could use some

fresh ideas and new enthusiasm. The problem the guild had several years ago was there were not enough people willing to step up and take on the work and responsibility. As a result the few that were doing the work became burned out. I hope that will not be the case again. Don't be afraid to step up to the plate. Just because you don't believe you are the most experienced Woodturner or Woodworker in the group doesn't mean you couldn't be the best president, secretary or treasurer. And as you get more involved I'll even bet your skills as a woodworker get better.

I personally enjoy organizing the guest demonstrators and if asked would gladly help in that role. I have also been serving as the librarian and expect to continue with those duties. I am sure I speak for all of the officers, current and past, in stating that we are happy to help any new officers in their new role.

He explained that a bowl that lacks figure or character can be improved by these techniques and customers are willing to pay more for a turning with these additions.
